## 1. Introduction

This document is the TSA disclosure statement, as required by European standard ETSI EN 319 421, related to the electronic time-stamping service offered by Coloriuris S.L. (in the following, just CIPSC).

## 4. Electronic time-stamps types and usage

---

CIPSC aims to deliver time-stamping services in accordance with the Regulation (EU) 910/2014 (“eIDAS Regulation”). CIPSC Time Stamps may be equally applied to any application requiring proof that a datum existed before a particular time on terms of the CIPSC TSA Policies and Practice Statements found at address: <https://cipsc.coloriuris.net/politicas/>

The following hash algorithms are accepted and supported:

- SHA-256

The signature of the time stamps issued is done by calculating the hash using SHA-256 and encrypting it with RSA algorithms, using a key with a length of at least 2048 bits.

The object-identifier (OID) of the CIPSC Time-Stamping Policy is: 1.3.6.1.4.1.37799.20.5.0.1.0. This OID is referenced in every CIPSC issued time-stamp and the CIPSC TSA Practice Statements. This Time Stamping Policy is based on the ETSI BTSP best practices policy for time-stamps (OID 0.4.0.2023.1.1).

The TSU certificate is issued by a self signed root CA. Details of the TSU certificate and the CA can be found at address: <https://cipsc.coloriuris.net/certificados/> and section 3.6 - TSACI Root Certificate and Seals of the CIPSC TSA Policies and Practice Statements.

## 5. Reliance limits

---

The accuracy of the time reference included in time-stamp tokens is  $\pm 1$  second, with reference to UTC (Universal Time Coordinated).

The information generated in the log file is kept online until being archived. Once archived, log files are kept for 7 years.

## 7. TSU public key certificate status checking obligations of relying parties

---

Before relying on a time-stamp token issued by CIPSC, relying parties must verify that the time-stamp token is correctly signed (that is, it contains a valid electronic signature) and that the TSU certificate is not revoked, by checking the suitable CRL at the address specified in the certificate itself.

## 14. TSP and repository licenses, trust marks, and audit:

Since December, 2011 CIPSC is Timestamp Services Provider enlisted in the public registry of the Spanish regulator.

As of September, 27 2017 CIPSC is a Qualified Trust Service Provider of Qualified Timestamps according to the eIDAS Regulation, and therefore enlisted in the Spanish List of Trust Service Providers (TSL) published by the Spanish regulator.

The TSA service provided by CIPSC is subject to regular conformity assessment according to the ETSI EN 319 401 and ETSI EN 319 421 norms, by an independent and accredited external auditor.
